Equity Price: \$1,000
Monthly Dues: \$335 plus tax

Equity Members receive unlimited golf, 20% discount on all Pro Shop purchases and 20% on food and beverage purchases as well as access to all Member's events, Vue on 30a, swimming pool, hot tub, and private beach. Locker usage, bag storage and driving range packages are available at additional charge. Equity Members own stock in the Club and are entitled to an exit refund upon resignation.

JUNIOR MEMBERSHIP

Junior Price: \$500 plus tax
Monthly Dues: \$205-\$251.25 plus tax
(excludes voting privileges)

Available to those under 40 years of age. Members enjoy the same privileges as Equity Members (excluding voting right) with unlimited golf, 20% discount on all Pro Shop and 20% on food and beverage purchases as well as access to Member's only events, Vue on 30a, swimming pool, hot tub, and private beach. Locker usage, bag storage, and driving range packages are available at additional charge. At age 35 dues change to 75% of the Equity Dues (\$335). At the age of 40, Junior Members have the option to upgrade to Equity at the prevailing price.

SOCIAL MEMBERSHIPS

Promotions are not available for social memberships at this time.

Social Price: \$1,500 plus tax
Monthly Dues: \$120 plus tax
(excludes voting privileges and is non-transferable)

Social Members receive reduced golf green fees, 20% discount on all Pro Shop purchases and 20% discount on food and beverage purchases as well as access to group golf games, Members-only events, Vue on 30a, swimming pool, hot tub, and private beach. Locker usage, bag storage, and the driving range are available at additional charge. Members have the option to upgrade to Equity at the prevailing price.
